## CHANGES TO THE HEALTH AND SAFETY (FIRST AID) REGULATIONS 1981

With effect from 1st October 2013, Health & Safety (First Aid) Regulations 1981 has been amended, removing the requirement for HSE to approve first aid training and qualifications.

We as a Company have therefore become an approved centre of AoFAQ (Association of First Aiders, Qualifications), an Ofqual recognized Awarding Organisation who since 2004 have grown to be UK's largest First Aid Association with over 3,500 members nationwide and who are associated with the Royal College of Surgeons (Edinburgh), and the Stroke Association.



## FIRST AID AT WORK REQUALIFYING COURSE (TWO DAY)

**(Certificated, valid for three years)**

To revalidate a First Aid at Work certificate for a further three years, the candidate must complete a **Re-qualification** course and pass assessment before expiry of their current certificate.

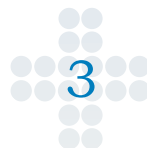

### From M11

Exit the M11 at Junction 7 and join the A414 Harlow Potter Street Bypass towards Harlow going through traffic lights (Harlow Park Inn Hotel on left). Remain on this road over next three roundabouts. At the fourth roundabout (Gates Garage on left) take the first exit onto Edinburgh Way (A414) going past Tesco on left. Continue over roundabout and turn right into Edinburgh place (Esso petrol station on corner). Stephen Taylor House is located on the left.

### From M25

Exit the M25 at Junction 27 and join the M11 towards Cambridge. Follow 'From M11'

### From A10

Leave the A10 at the 'A414/Harlow' slip road exit. Follow the A414 to the third roundabout and take the first exit to join Edinburgh way (A414) Continue straight over two roundabouts. turn left into Edinburgh Place (ESSO Petrol Station on the Corner). Stephen Taylor House is Located on the left.
